MS 0510 COMMONWEALTH MINING AND MILLING CO. Papers, 1895-1934

DESCRIPTION

Company correspondence, newspaper clippings, profit and loan information, business receipts and bank statements of the Commonwealth Mining and Milling Co. between 1910 and 1921. A photograph of the original 1895 location notice for the mine along with a map highlight this collection. Four folders contain bank statements, cancelled checks, and expense vouchers for mine purchases during the period 1913-1921. Newspaper clippings document the mine's destruction by fire in March 1910. One outside item in the oversized storage contains mine monthly pay roll information for the period Aug.- Sep. of 1914 and Jan. – Mar. of 1915. This collection includes former MS 1345 – Commonwealth Mining and Milling Company Records.

HISTORICAL NOTE

The Commonwealth Mine, also known as the Commonwealth Development Company and the Commonwealth Mining and Milling Company, was located at Pearce, AZ in the Sulphur Springs Valley in the southeastern corner of Arizona. The original mine was discovered in 1895 by James Pearce who owned a ranch in the area and had previously worked as a miner in the Tombstone area. The Pearce family started removing the rich gold and silver ore to Willcox, AZ after which it was transported to a smelter in El Paso, TX. As news of the rich mine became known, Pearce received offers by various individuals to purchase the claim. Investors in Philadelphia purchased the mine paying Pearce \$240,000 for the claim and forming the Commonwealth Mining and Milling Company. In 1903 as the grade of ore declined a reorganization placed John Brockman and A. Y. Smith as managers. In 1905 the mine was leased to Smith and D. T. Swatling. In 1909 the cyanide plant constructed at the mine by Smith and Swatling burned and mining operations halted. In 1910 the mine was sold to Montana Tonopah Mining and Milling Company which promptly hired A. Y. Smith to manage the property. In 1918 the mine was again reorganized under the new designation Commonwealth Development Company and remained in operation until 1930 when falling silver prices forced the mine to close for the final time.

ACQUISITION

Unknown. This collection also includes former MS 1345 which was donated by Janolyn Lo Vecchio in September 2008 and one journal which was donated by Mr. And Mrs. Max Millett and Don Pace in February 1975.

ACCESS

There are no restrictions on access to this collection.
