Correspondence, banking records, business receipts, contracts, agreements, and ledgers relating to the Jacobs family's pioneer mercantile and banking enterprises in southern Arizona.

The collection is arranged in six series: Correspondence, 1868-1892. Business receipts, 1868-1917. Contracts and agreements, 1872-1890. Ledgers, 1869-1912. Banking records, 1879-1896. Banking records: Checks, etc., 1878-1916.

## **BIOGRAPHICAL NOTE**

Pioneer southern Arizona merchants and bankers; Lionel and Barron Jacobs arrived in Tucson in 1867 to open a branch of M.I. Jacobs and Company, a general store. Their father, Mark I. Jacobs remained in California, where he purchased goods and managed operations by mail until his retirement in 1875. When Mark Jacobs retired, the store was renamed L.M. Jacobs and Company. Other Jacobs' relatives were sent to Safford (Abraham M. Franklin) and to Florence (Martin Calisher) to operate store branches. In 1879, the family established the Pima County Bank, the first bank in Tucson. In 1880, L.M. Jacobs and Co. quit their merchant business to focus on banking. They were later associated with the First National Bank, Cochise County Bank, Santa Cruz Valley Bank, Consolidated National Bank, and Arizona National Bank. Both brothers retired from banking in 1913 or 1914; Lionel died in 1922 and Barron died in 1936.

#### **SCOPE AND CONTENT NOTE**

Correspondence, banking records, legal records, and business receipts document the economics of business in territorial Arizona and provide a detailed record of the Jacobs family's business operations. Correspondence is chiefly between Mark Jacobs and his sons, Lionel and Barron, and mostly concerns their mercantile business but also includes personal matters. The rest is from suppliers and freighters concerning arrangements for goods. Receipts are present from suppliers which show amounts paid and quantities ordered for store merchandise. Ledgers include a day book and a ledger book for 1869, listing customers, purchases, and amounts. Customers include John B. Allen, Leopoldo Carrillo, Charles Shibbell, Mark Aldrich, P.R. Tully, and many other local pioneers.

Contracts and agreements include City of Tucson indentures for property, mining location notices, a contract for purchase of a mule and wagon train, and fees for legal services. Bank records consist of correspondence and transaction records between banks for the transfer of monies. There are also deposit slips, checks, bank drafts, and certificates of deposit from the banks under their management, and a journal for First National Bank, 1882 to 1885, which lists customers' daily account balances. An essay by L.M. Jacobs, "Banking in Arizona," considers the usefulness of banks, the banker's status, and the reputation of banking in Arizona. It was written about 1900.
