#### **BIOGRAPHICAL NOTE**

Leon F. Kneipp served in the Forest Service for nearly forty-seven years, beginning in 1900 when the forest service was part of the Department of the Interior. He began his career as a forest ranger assigned to the Prescott Forest Reserve in Arizona. He served in a number of positions and was made assistance chief of the Forest Service and district forester in charge of Forest Service Operations at Ogden Utah. For the twenty-five years before his retirement in 1947, he was assistant chief in charge of land acquisition and planning. He was a pioneer in the movement for preservation of wilderness tracts.

#### SCOPE AND CONTENT NOTE

The Kneipp collection includes material which will be of interest to those studying the development of the U. S. Forest Service in the early twentieth century. The entire collection is really Forest Service materials as the "personal" papers in the collection are all related to Kneipp's career with the Forest Service. Correspondence included in the collection is all concerning Forest Service matters or general conservation issues. There is a small amount of correspondence with notable conservationists including Gifford Pinchot and Aldo Leopold.

The series on Kneipp's 1935 trip to Germany will of be of interest to those studying the development of the Forest Service to see if Kneipp's interest in the management of Austrian Forests was further developed in his work. The "notes and notebooks" series is one which Kneipp seems to have developed himself and gives his thoughts as well as talks and work on issues such as grazing rights, outdoor recreation and conservation of natural resources.
