HISTORICAL NOTE: The League of Women Voters of the United States was founded on February 14,1920, by Carrie Chapman Catt, a leader of the women's suffrage movement. Catt believed that once the 19th Amendment was passed, the League of Women Voters would be a "mighty political experiment" designed to help 20 million women carry out their new responsibilities as voters. From the beginning, the League was a nonpartisan organization. Initially, the League focused its efforts on voter registration and political participation among women, but later broadened these efforts to reach all Americans.

The League of Women Voters of Greater Tucson (LWVGT) was established on May 16, 1941 by a group of 34 women. The founders included Mary Jeffries Bruce, Helen Congdon D'Autremont, Ora DeConcini, Georgie Scott Forbes, Margaret Knight, Kathryn Maxwell, Ada McCormick, Margaret Sanger, and Grace Sternberg. The LWVGT priorities included voter registration; analyzing local, state, and national issues; and educating the public on local government and ballot issues. The league hosted local candidate forums and debates in Tucson, and members developed education programs such as Women for a Change, Issues and Eggs, and Running and Winning. The LWVGT also participated in global efforts such as the Kenya Global Democracy Project. Today they continue to investigate and develop positions on many issues such as Tucson's urban growth, redistricting in Arizona, health care, immigration, and transportation. Some of the LWVGT's achievements in its history include:

- Advocated for an Arizona state law allowing women to serve on juries.
- Advocated for the Tucson Master Plan on urban growth.
- Advocated for an Arizona state law for merit selection of judges.
- Advocated for the Arizona Motor Voter Law which made it possible to register to vote when obtaining a driver's license.
- Advocated for an Arizona state law funding free textbooks for Arizona students.
- Advocated for an Independent Redistricting Commission initiative.
- Developed program positions on energy, education finance, clean air, water resources, affordable housing, money in politics, and charter schools.
- Ensured that every vote was counted in the November 2018 election by joining in the Amicus Brief.

SCOPE AND CONTENT NOTE: This collection is arranged in three series:

Series I: League of Women Voters of Greater Tucson records Series II: League of Women Voters of Arizona records Series III: League of Women Voters of the United States material

Series I contains the bulk of the collection. It includes records and office material created by the League of Women Voters of Greater Tucson, including annual meetings, annual reports, board of directors' meeting minutes and agendas (which occasionally includes budget information and other material), budget and financial records, event programs, histories of the local league, newsletters, newspaper clippings about league events and members, photographs, program position drafts and research material on local issues, songs, speeches, workshop training material, and many guides published for local residents on how to register to vote, directories of elected officials, and city and county offices and services.

Series II includes a small amount of records from the League of Women Voters of Arizona, such as board meeting material, annual reports, action agendas, budgets, newsletters, histories, and directories of other local leagues.

Series III contains some material from the League of Women Voters of the United States headquarters in Washington, D.C, including publications, an audio recording of a speech by a national president, and material sent by the national office for local presidents and board members on how to operate a local league.
