DESCRIPTION

This collection consists of correspondence and business records of Andrew P. Martin and the Martin Drug Co. The materials within this collection entails letters, receipts, tax documents, and family papers. In addition to extensive correspondence of the Martin Drug Co. numerous letters involve the American Legion, the formation of the first National Guard unit in Tucson, and political correspondence with prominent Arizona leaders.

Biographical Note

Andrew P. Martin, pioneer druggist and life-long resident of Tucson, was born September 13, 1886. His father, George Martin Sr., came to Tucson and established a drugstore in 1882. He entered his father's drug store business at the age of 10 and built the Martin Drug Co. to eight stores in Tucson and Casa Grande. In 1904 he became a registered pharmacist through training in his father's store and attending classes at the University of Arizona. Martin sold the company in 1954 to Ryan-Evans of Phoenix.

Martin's political life and correspondence with state officials was extensive. A life-long member of the Democratic Party he maintained contacts with state governors, representatives, and local political members. In 1912 he ran for the Arizona seat in the House of Representatives and although not elected did go to Washington as secretary to Senator Carl Hayden. Martin served one term in the Arizona State Senate from 1914-1916. He was a member of the Tucson Merchants Association, president of the Tucson Chamber of Commerce in 1916, and served on the committee drafting the city charter in 1929.

Martin maintained a life-long association with the armed forces and civic affiliations. He attended the University of Arizona and participated in the University is cadet battalion as a captain. In 1910, the year he graduated, he organized a new National Guard company in Tucson and performed as its commander. When the United States entered World War I Martin enlisted as a Private, was promoted to Sergeant, and served overseas in actions at St. Mihiel and in the Meuse-Argonne offensive. At the conclusion of the war he served with the occupation force in Germany until his discharge. During World War II he became a member of the Selective Service Board. He was associated with the Eagles, Elks, Knights of Columbus, Forty and Eight, Rotary Club, the Sun-Shine Climate Club, and other druggists' associations. Martin pushed for the organization of the American Legion in the state and became its first state commander.

A long-time supporter of the University of Arizona Martin was instrumental in establishing the Pharmacy College. He died January 27, 1969 at the age of 82.

Scope and Content Note

The papers of Andrew P. Martin represent correspondence associated with personal, political, and business endeavors covering the years 1889 to 1970 in Tucson, Arizona. The papers are in good condition and the collection was extensively inventoried by the Historical Society then reorganized and consolidated in 1998. The papers have been divided into ten series – Personal Correspondence, Political Correspondence, Carl Hayden Papers, American Legion Correspondence, National Guard Papers, Martin Family Correspondence, Tucson Merchants Association Papers, Martin Securities and Investments, Martin Drug Co. Papers, and Ledgers of Business Accounts. Files containing extensive correspondence with individuals or business organizations have been arranged by the last names and clipped together for easier reference. NOTE: Politicians and others can be found in correspondence throughout the collection including the Personal series.

Series I: Personal Correspondence, 1911-1969 (Boxes 1, 2, 3, and 4 with 25 Folders). Covers Martin's correspondence with state and national individuals. Although the letters discuss some political business they are from Martin's personal or private citizen standpoint rather than as another elected official. Communications also consists of letters between Martin, as president of Martin Drug Co., and regional-national drug suppliers. In addition, personal letters of recommendation for individuals from the Tucson area seeking state and national jobs are included.

Series II: Political Correspondence, 1911-1967 (Box 4 with 2 Folders). Exchange of letters on diverse political issues and concerns to the state of Arizona between Martin, Arizona governors, and legislative leaders. Issues concern pharmacy legislation, Indian reservation concerns, and correspondence between members of the Democratic Central Committee (of which Martin was a life-long member).

Series III: Carl Hayden Papers, 1911-1968 (Boxes 4 and 5 with 11 Folders). Papers contain correspondence associated with Senator Carl Hayden from 1912 to 1968. It is apparent that these two men enjoyed a life-long friendship and correspondence. Martin served as Hayden's secretary in Washington in 1912. Some papers entail letters to Hayden in Washington which Martin maintained copies while other letters addressed to Martin are from or about Carl Hayden and proposed political actions or concerns. Martin also served as the committee chairman for the Carl Hayden Golden Anniversary Dinner on Nov. 17, 1961.

Series IV. American Legion Papers, 1911-1968 (Boxes 5, 6, and 7 with 12 Folders). Martin was one of the founders of the American Legion Post in Tucson and served as its first commander in 1919. The collection entails extensive correspondence between Martin and members in the period 1919 and 1920. Membership information as well as a copy of the Legion Constitution for 1919 are enclosed. Also contained are awards and certificates presented to Martin for service to the American Legion.

Series V. National Guard Papers, 1909-1919 (Box 7 with 2 Folders). Martin was instrumental in organizing and commanding the one of the first National Guard unit in Tucson (Company K) in 1909-1910. Correspondence between Martin, higher headquarters in Phoenix, and additional commanders and members demonstrates the difficulties of organizing this new unit from scratch.

Series VI. Martin Family Papers, 1882-1970 (Boxes 7, 8, and 9 with 16 Folders). Series consists of documents, correspondence, legal papers of various members of the Martin

family. Eight folders contain receipts and financial statements associated with Mary A. Martin (Andrew's sister) and the Martin Drug Co. of Tucson. Mary served as the book keeper for the store until 1944.

Series VII. Tucson Merchants Association, 1922-1927 (Boxes 9 and 10 - 3 Folders). Martin maintained extensive business contacts with national, state, and city representatives. He was a life-long member of the Tucson Merchants Association and served as president of the Tucson Chamber of Commerce in 1916. Papers in this series reflect correspondence of Martin with these activities.

Series VIII. Martin Securities and Investments, 1902 – 1957 (Boxes 10 and 11 with 8 Folders). Through his extensive business contacts Martin had many real estate investment correspondence associated with property in Tucson and surrounding areas. Mining certificates and reports are also included.

Series IX. Martin Drug Co. Papers, 1901 – 1954 (Boxes 11 and 12 with 9 Folders). Series contains correspondence with customers and suppliers for the period 1901 – 1954. Letters request information on availability of certain drugs by purchasers as well as Martin's correspondence with national drug suppliers.

Series X. Business Account Ledgers, 1885-1911 (Boxes 13, 14, 15 and 16). All ledgers are associated with the Martin Drug Co. in the form of business accounts, wages, or customer orders.
