MS 1077 Medigovich, Sam V. Collection, 1881-1974

DESCRIPTION

This collection consists of City of Tombstone official records and other materials collected by Sam and Theda Medigovich. City of Tombstone official records include financial reports, legal documents, correspondence, ordinances, contracts, ledgers, election materials, and more. The remainder of the collection contains correspondence, legal documents, research notes, reports, printed material, and photographs relating to Tombstone, Ariz., the Tombstone Restoration Commission, and individuals, organizations, and businesses in Tombstone.

ACQUISITION

The collection was donated by Sam Medigovich on June 6, 1985.

RELATED MATERIAL

The Jared Taylor Papers, MS 1078, were received from Sam Medigovich in the same donation as this collection. Taylor was an attorney in Bisbee and Tombstone from 1906 to the 1940s.

TRANSFER

Several U.S.G.S. maps and panoramas of a group of Bisbee men leaving for World War I were transferred to those areas.

ACCESS

There are no restrictions on access to this collection. Some fragile materials are stored in the Rare Cage but photocopies are available in the files for patron use.

PROCESSING

The collection was processed by Alice Holmes, prior to 1996, and by Kim Frontz, September 1997.

BIOGRAPHICAL AND HISTORICAL NOTE

Sam and Theda Medigovich owned and operated the Wagon Wheel Restaurant and the Silver Nugget Museum in Tombstone, Ariz. from the 1940s to the 1980s. They were members of the Tombstone Restoration Commission and Theda served as it President at one time. They were active in collecting, preserving and recreating Tombstone's history.

The Tombstone Restoration Commission was formed in the 1940s by the residents of Tombstone, as a non-profit organization, to restore the exteriors of existing buildings to their original appearance, to restore plank sidewalks, to remove evidence of modern conveniences such as telephone lines from view, and to restore locations significant to Tombstone's legends and history.

The Tombstone Town Association formed on March 5, 1879; and by 1881, it had become one of the largest cities in the West. Larger than San Francisco, it was briefly one of the most cultured cities west of the Mississippi. The town flourished until 1886 when the mines began flooding and many people moved on to other places. Tombstone was also the county seat for Cochise County from 1881 to 1929. It has since become famous as the site of the OK Corral shoot out which occurred in 1881 between the Clanton and McLaury brothers and Doc Holliday and the Earp brothers.

SCOPE AND CONTENT NOTE

The collection documents the workings of a City government from its beginnings as a frontier western mining community in 1881 to the period of Arizona's statehood, and also includes documentation of a Federal public works project for gas and electric services in the 1930s. There are also various collections of materials concerning the people, organizations, and businesses of Tombstone and documentation of the work of the Tombstone Restoration Commission.

The City of Tombstone records, chiefly from 1881 to 1912, depict in detail the operations of City government. The records of the Mayor and Council include appointments, resignations and oaths of office of City officials, petitions received from citizens regarding issues such as unpassable streets, filthy conditions, and public drunkenness, and ordinances passed relating to elections, saloon operations, prostitution, traffic and more. There are monthly summary reports from the various City departments reporting monies received, fines levied, business licenses issued, etc.

The election process can be followed through the nominating petitions, poll lists, tally sheets, and other documents from the City Clerk. Land transactions, ownership, and surveys are also documented on a case by case basis. The City Recorder reported monthly the number of arrests, trials, and types of crimes; and the Police Department records include a police blotter, 1888 to 1890, that details the arrestee's name, offense and disposition of the arrest. In addition, there are examples of wanted posters sent to Tombstone from other jurisdictions. The Police Dept. and License Tax Collector were often headed by the same person so these records may be found in either place over time.

Sam and Theda Medigovich also gathered an eclectic collection of original documents that provide information about some of Tombstone's residents, businesses and organizations. These include invoices and receipts of J. Goldwater & Co. Merchants and documents of the Ancient Order of United Workmen, Tombstone Chapter.

The Restoration Commission documents include financial reports, plans of the Arizona State Parks Board, brochures, correspondence and printed material. Some of the

commission members also have correspondence and writings in the collection including Edna Landin who was President of the Commission and also served as President of the Tombstone Chamber of Commerce. Correspondence, invoices and printed material, written mostly in Chinese, are present from Yee Wee, a grocer in Elfrida, Arizona. There are also personal materials of Sam and Theda Medigovich. Photographs include portraits taken by C.S. Fly, an early Tombstone photographer and more recent scenes from Tombstone's annual Helldorado celebrations.

Researchers interested in the OK Corral shoot out will not find any specific information relating to that event. There are a few reports signed by Virgil Earp in the course of his police duties and the Earps' names appear in business license lists. However, the collection is rich in information concerning the frontier environment and the business of the town in later years.
