DESCRIPTION

Transcripts and depositions from Court Cases in Arizona. The bulk of the collection is from Pima County Superior Court but also includes cases from the Supreme Court of Arizona, the U. S. District Court and other Arizona county superior courts. Also includes papers from Murphy's tenure as president of the Arizona State Bar Association and Arizona Pioneer's Historical Society. Also includes files of newspaper clippings on Arizona lawyers and law related activities as well as a small amount of photographs on the same topics.

BIOGRAPHICAL NOTE

James M. Murphy, Tucson attorney, was born in Tucson in 1917 to a pioneer Tucson family. He was educated at St. Joseph Academy, Tucson High School, University of Notre Dame and the University of Arizona law school. He served three years with the F.B.I. before serving in the Navy during World War II. Upon returning to Tucson in 1946, he became Deputy County Attorney for one year and then joined the law firm of Conner and Jones. Murphy later started his own law firm of Murphy, Goering and Roberts where he practiced law until his retirement in 1991. He was very active in the Tucson community as well as bar associations. He served as president of the Arizona Historical Society, the Old Pueblo Club, the Pima County Bar Association, the State Bar Association of Arizona and was a director of the American Bar Association. He served as lecturer on business law at the University of Arizona. He combined his interests in Southwestern history and the law and wrote two books entitled *Spanish Legal Heritage in Arizona* and *Law, Courts and Lawyers*. He died in 1997.

SCOPE AND CONTENT NOTE

Collection contains Murphy's interest in the legal history of Arizona. Murphy's research on law in Arizona is contained in the first series along with his work with the Arizona State Bar Association. The collection of court cases and depositions includes both cases on which Murphy worked as well as cases in which he researched. The bulk of the collection are the cases from Pima County, but other counties including Apache, Cochise, Gila, Graham, Navajo, Pinal and Santa Cruz are also represented. Cases from Arizona's Supreme Court as well as the U. S. District Court are also included. A case involving a Greyhound Bus Accident in 1959 was a major case in the collection.

Very little correspondence is included in the collection. Murphy's correspondence as president of the State Bar Association is included in the first series, but there is very little correspondence in the rest of the collection. The Cochise County Superior Court cases in Series 3 include the correspondence of Frank E. Thomas, 1958-1960.

Newspaper clippings of Arizona law and lawyers will be useful to researchers looking for information on this topic during the 1950s and 1960s.

SERIES NOTES

Series 1 : Professional Organizations & Correspondence, 1955-1960.

Murphy's work with professional and volunteer organizations. Five boxes (2.25 linear ft.), this series is arranged by name of organization and then chronologically. It includes Murphy's tenure as president of the Arizona State Bar Association (1955-1957 as well as Murphy's work as President of the Arizona Pioneer's Historical Society (1960-1967).

Series 2 : Pima County Superior Court Cases, 1928-1967.

Civil cases in the Pima County Superior Court. These cases are sometimes trial transcripts, but more often they are depositions of civil cases. This series is arranged chronologically and then alphabetically by the first name on the civil action. 49 boxes (24 linear ft.).

Series 3 : Arizona County Superior Courts (Not Pima County), 1922-1965.

Very incomplete set of Civil Court cases from other Arizona Counties, including Cochise, Gila, Graham, Navajo and Santa Cruz Counties. Ten boxes (5 linear ft.) arranged by name of County and then by date. The Cochise County section includes copies of the correspondence of Frank E. Thomas, 1958-1960.

Series 4 : U. S. District Court, 1927-1964.

Very incomplete set of Civil Court cases from the U. S. District Court in Arizona. Five boxes (2.5 linear ft.) arranged chronologically and then alphabetically by the first name on the civil action.

Series 5 : Supreme Court of Arizona, 1909-1965.

Very incomplete set of Civil Court cases Supreme Court of the State of Arizona (one case is from the Territory). Ten boxes (5 linear ft.) arranged chronologically and then alphabetically by the first name on the civil action.

Series 6 : Arizona Court of Impeachment, 1964.

Set (32 volumes) of the Arizona Court of Impeachment in the matter of the impeachment of A. P. "Jack" Buzard and E. T. "Eddie Williams, Jr. Four boxes (2 linear ft.) arranged by page numbers. Buzard and Williams were Democratic members of the Arizona Tax Commission and were charged with bribery and conspiracy. Both were acquitted.

Series 7 : Miscellaneous Court Cases, 1931-1966.

Transcripts of trials from the Tucson City Court, the Industrial Commission of Arizona, Justice Courts #1 & 2, and the U. S. Court of Appeals.

Series 8 : Lawyer Newspaper clippings, 1950-1966.

Murphy's collections of newspaper clippings on lawyers and judges in Arizona. Biographical clippings on law careers in Arizona. Also includes clippings on the various bar associations around the state (county and Arizona State Bar). 6 boxes (3 linear ft.) arranged alphabetically.

Series 9 : Photographs, ca. 1913-1963.

Primarily photographs of lawyers arranged as portrait files. Includes James Murphy, Morris Udall, Henry Fountain Ashurst and others. Also includes photographs of the interiors of unidentified law offices in 1913 and two photographs of an unidentified grain silo at a railroad. Group photographs include the Pima County Bar Association and the State Bar Association of Arizona. 1 box (.5 linear ft.) arranged topically.
