## 7. AHS FY25 budget – David Breeckner

- a. Report on meeting with Governor's team 6/2/23
  - i. The Governor's team cannot currently support the proposed budget; this is due to political realities impacting their reach. The Governor's Team does recognize the need for an increased budget and would likely support the request if it is initiated with legislative support.
  - ii. It is recommended that AHS secure a "champion" among the Legislature to propel this effort.

## b. Next steps

- i. **Action Item** to recommend one of the three draft FY25 budgets provided for the Executive Committee at its June meeting.
  - 1. Option A: \$1.45m increase
  - 2. Option B: \$884k increase
  - 3. Option C: \$428k increase (resolve existing deficit)
    - A lively discussion preceded a motion to recommend one of the three aforementioned budget options. Committee members shared previous experience with "securing a Legislative Champion(s)" for initiatives within their respective communities. It was suggested that AHS create a financial "fact book/pamphlet" to disperse to members of the Legislature and as a point of reference for State Board members.
    - Richard Powers motioned to recommend Option A: \$1.45m increase of the draft FY25 budget to the Executive Committee.
    - Second- Gene Kunde
