DESCRIPTION

This collection consists of boxed material dealing with Lt. Gallagher's services in the 106th Pennsylvania Regiment during the Civil War and subsequent appointment to the 32nd Infantry, being stationed first in Washington and later in Arizona Territory.

This collection was purchased by the Arizona Historical Society from Griffith Military Antiques, Evans, Georgia, in August, 2002.

PROCESSING

This collection was processed by Charles H. Herner, under the supervision of the Archivist in 2007-2008.

ARRANGEMENT

Letter sized material in this collection is filed chronologically, 1864-1871, in five standard archival boxes containing a total of 148 folders.

327 oversized items are filed chronologically in seven oversized boxes numbered 6 through 12. This collection contains no components such as series or sub-divisions.

BIOGRAPHICAL NOTE

John M. Gallagher was born in 1840 in Philadelphia. Following the outbreak of the Civil War, he enlisted in the 18th Pennsylvania Infantry, later transferring to the 108th Pennsylvania Infantry, where he was promoted to volunteer captain. After the war, Lt. Gallagher served briefly in the 14th Infantry. Later transferred to the 32nd Infantry, he marched from Washington Territory to Arizona, arriving at Camp Wallen in 1867. Promoted to captain the following year, Gallagher was held responsible for five supply mules lost from

a pack train under his supervision. He was mustered out of service in 1871 and died Jan. 2, 1872.

SCOPE AND CONTENT NOTE

This collection consists of 16 boxes of manuscript material arranged chronologically. The vast majority of these documents trace the accountability of government property issued to individuals, units and military installations in southern Arizona. Typical items include monthly and quarterly returns of clothing, camp equipment, ordnance and quartermaster stores. Included also are routine records such as civilian payrolls, records of rations drawn for issue, reports of survey, and disposition of material lost through neglect or fair wear and use. Lt. Gallagher issued many of the military documents from the Tucson Camp Lowell location while other documents originated at other Arizona Territory military locations including Camp Goodwin and Wallen. Additional military supply documents are associated with military posts and camps outside the southwest including Fort Lapwai (Indian Territory), Camp Crossman (Pennsylvania), and Fort Vancouver (Western Territory). What unites these documents is their subject matter dealing with supply and administrative instructions in support of western military operations and that they were drafted by, addressed to, or retained by Gallagher.

This collection will prove useful to researchers concerned with the logistical paper trail associated with efforts to maintain and support military establishments in southern Arizona immediately following the Civil War. Researchers interested in general military operations, however, will be disappointed that the collection contains no descriptions of unit activities involving scouting missions, incident reports, or relations with hostile Indians. Also missing from this collection are key personnel and important unit records such as muster rolls and post returns.
