DESCRIPTION

This collection consists of documents and records accumulated during the day to day operation of the Hayden Construction and Excavation Company Inc. The collection includes bank statements, ledger books, stationery, tax forms, personal letters, photos, and statements of financial activities. The bulk of the collection is made up of billing statements for clients and correspondence with business partners between the years 1945 and 1978. Incorporation records are included in the collection. Non-business documents in the collection include estate planning records and letters of recognition for charitable giving. Charitable giving records offer a view into what was most important to Julian D. Hayden apart from his business. Other articles of interest in the collection include a manual for septic system users written by Julian D. Hayden, titled "The Facts of Life with Septic tanks."

BIOGRAPHICAL NOTE

Julian D. Hayden was born in January 1911, in Hamilton Montana. He died in Tucson on March 6, 1998. Hayden and his family moved to Tucson in 1946. His father, Irwin Hayden, earned a Master's Degree in Archeology from Harvard. Hayden completed two years of college, but never earned a degree. With training from his father, Julian D. Hayden became a respected amateur archaeologist. He had a passion for studying ancient people groups that inhabited the area around Tucson. Hayden was considered an expert on the ancient inhabitants of the Pinacate, a volcanic region just south of the Arizona, Mexico border. The only reference to these activities in this collection are a few records related to Mr. Hayden's appointment as a research associate with the University of Arizona's Arizona State Museum.

Hayden Excavation and Construction Service was a Tucson business from 1945 to 1979. The company provided services related to the installation and maintenance of septic systems for business and residential clients. In addition to repairing and installing sewage disposal systems, the company also provided pre-cast sewer manholes and pre-cast septic tanks, along with backhoes, trucks, and loading service for excavation. The business operated as a sole proprietorship for most of its history other than a brief period of incorporation from 1972-1979.
