DESCRIPTION

Mr. William J. Holliday's collection of documents is a series of unrelated Mexican documents handwritten in Spanish. The majority of the documents are public records that were recorded by different notary publics in Zaragoza, Puebla Mexico. Most of those papers dealt with land sales, house sales, mortgage payments, debts and other legal matters such as court proceedings. Besides the documents from the state of Puebla, this collection includes correspondence to and from the Mexican State of Jalisco, a petition from the State of Sonora, and receipts of payments of taxes and fees from the city of Mexico. The time period of the documents within the collection range from the years 1839 to 1905 covering many different people and unrelated events.
