BIOGRAPHICAL NOTE: Douglas Holsclaw was born on July 31, 1898 in Grangeville, Idaho to John and Abbie Holsclaw. In 1918 he joined the military. While attending Officers' Training Camp in Moscow, Idaho, he contracted tuberculosis. For the next 25 months he spent time in several Veterans hospitals, finally ending up in Tucson in 1921. The same year he entered the University of Arizona. Apart from his studies, he played in the University band, served as Yell Leader, and was a founding member of Delta Chi Fraternity. In 1925 he received a Bachelor of Science degree with high distinction. He later attended Harvard Medical School on scholarship, but a second breakdown with tuberculosis forced him to return to Tucson in the fall of 1927. Over the next few years, Holsclaw was in and out of Veterans hospitals in Arizona, California, and Illinois.

Although hospitalized for much of a 7-year period, during which he underwent eleven operations on his sinuses, Holsclaw was far from idle. From his bed he wrote the University of Arizona fight song "Fight, Wildcats, Fight." In 1930 he ran, unsuccessfully, for a seat in the state senate on the Republican ticket. Holsclaw found that he could sell insurance from his bed and for six years he represented the New York Life Insurance Company. In 1932 he wed the former Alice Young in a ceremony held in his hospital room. Upon Douglas' full recovery, the Holsclaws owned and operated the Pima Realty and Insurance Company from 1936 until they retired in 1947.

Holsclaw authored a 1935 federal bill, sponsored by Arizona Congresswoman Isabella Greenway, protecting veterans from restrictions in the Homestead Act. Long active in the Republican Party, Holsclaw served as a ward, precinct, and state committeeman. In 1950, he enrolled in the University of Arizona Law School to prepare for what he hoped would be a second career in the state legislature. His hopes were realized in 1952 when the voters of Pima County elected him to the Arizona State House of Representatives.

Throughout Holsclaw's 22-year career in the state legislature (14 in the House, 8 in the Senate), he was an advocate of legislation in the fields of education, health, welfare, and the environment. He worked hard to pass legislation to educate, train, and rehabilitate the mentally and physically disabled and public offenders. In addition, he helped in the development and support of community-based programs to deal with mental health and substance abuse issues at the local level. Heralded by his peers as "an environmentalist ahead of his time," Holsclaw pushed for air pollution control measures

related to automobiles, mining, and smoking. A strong advocate of education at all levels, he played a major role in the affairs of the state's three universities, helping to establish the College of Medicine at the University of Arizona. His legislative legacy includes over 200 laws and memorials that he either sponsored or co-sponsored during his tenure.

Holsclaw suffered defeat in the 1974 general election, losing to Democrat Sue Dye. He attributed the loss to a nationwide backlash against Republicans in the aftermath of Watergate. In 1978, the Arizona State Senate passed by a unanimous vote a resolution proclaiming May 17 as "Senator Holsclaw Day." As of the creation of this finding aid is the only former legislator to be so honored.

Throughout his life, Douglas Holsclaw was involved in community and fraternal organizations and served on many boards. A Mason and Shriner, he also belonged to other groups including the American Legion, Arizona Historical Society, Disabled American Veterans, Tucson Rotary Club, Sons of the American Revolution, and Veterans of World War I. He served on the board of the Beacon Foundation, Pima Council on Aging, Southern Arizona Council on Alcoholism, Tucson Boys Clubs, and Pima County and Arizona Mental Health Associations, to name a few. In addition, he was the recipient of numerous state, civic, and national awards. His honors included the Carnegie Human Relations Award (1962), Tucson Man of the Year Award (1969), Arizonans for Quality of Environment Award (1972), Doctor of Humane Letters (University of Arizona, 1974), Arizona Recovery centers Association Award (1975), and Arizona Senior Citizen of the Year (1975).

Alice Young Holsclaw was born in St. Louis, Missouri in 1902. She graduated from Butler University in Indianapolis, Indiana with an emphasis on English, music, and education. In 1928, Alice moved to Tucson to operate the Sunshine Elementary School, a private facility. It was in Tucson where she met Douglas through a mutual friend. Alice worked alongside her husband during his years in the state legislature, helping with research and secretarial duties. Sharing Douglas' keen civic awareness, her community involvement included membership in the Tucson Symphony, Arizona-Sonora Desert Museum, Tucson Women's Club, Pima County Republican Women's Club, Tucson Botanical Gardens, and the Daughters of the American Revolution.

Together, the Holsclaws gave to state and local organizations and charities. As longtime supporters of the University of Arizona, their contributions helped with the building of the College of Medicine. They later donated \$500,000 to establish a professorship in genetic research. Subsequent gifts resulted in the building of a new recital hall of the University of Arizona School of Music, a downtown Young Men's Christian Association facility, and the remodeling of the Temple of Music and Art.

Alice Holsclaw passed away in 1990. Douglas continued to reside in Tucson until his death in February 1995. They were survived by their son, Douglas Holsclaw, Jr.

SCOPE AND CONTENT NOTE: Contains correspondence, memoranda, minutes, notes, printed matter, photographs, and artifacts. The bulk of the material concerns Holsclaw's legislative and civic activities from 1952-1985. The collection reflects Holsclaw's career as a legislator and community activist.

The collection was arranged and labeled with Holsclaw's original order, naming, and filing system in place. With the exception of some boxes of loose papers, Holsclaw's file folder headings remain as he created them. Therefore, many types of materials are found in a folder (e.g. correspondence, memoranda, notes, reports, bills), as folders are not necessarily in chronological order, although inclusive dates of the folders are present. Some folders have identical headings and dates that overlap, and remain in this way to maintain the file creator's original order.

Arranged in five series: 1. Personal files; 2. Legislative activities; 3. Civic activities; 4. Business activities; 5. Photographs and oversize materials. All folder are arranged alphabetically by topic.

Series 1: Personal files - Consists of biographical information, personal correspondence, vanity files (e.g. clippings, awards, and recognitions), donations, and campaign files. The folders labelled "Campaign Material" contain flyers, correspondence, notes, advertisements, newspaper clippings, memorabilia, receipts, and a loyalty oath (signed by Holsclaw in 1955, proclaiming his support of the U.S. Constitution). Holsclaw refused to accept campaign contributions - even from his own party - as evidenced by his campaign expenses. Also in the series are several folders labelled "Personal." These folders contain correspondence, cards, notes, and photographs. Some of the material relates to Holsclaw's civic and legislative activities; however, because he chose to title them "Personal," they have been placed in this series.

Series 2: Legislative activities - Contains drafts of bills, supporting legislative material, correspondence, notes, meeting minutes, and memoranda. During his career, Holsclaw served on every committee, including Appropriations, Education, Labor, Public Health, State Government, and Welfare. The bulk of the material in this series reflects his work on specific pieces of legislation. Holsclaw was involved in all facets of education-related legislation. He worked hard to implement and enforce pollution guidelines related to mining, motor vehicles, and smoking. He helped to pass tough drunk driving laws while creating avenues for substance abusers to seek treatment. A veteran himself, he was deeply involved in veteran's issues. He pushed for prison reform and rehabilitation, was an advocate for the mentally ill, and a leader in legislation benefitting the disabled. The series contains an impressive array of correspondence concerning the civil rights movement in Arizona and Holsclaw sponsored or co-sponsored several anti-discrimination bills.

Some of the material details other duties performed while in office such as correspondence with constituents (e.g. request for assistance, usually in the form of "I want," "I don't want," "I believe," and "Please help me"), letters of recommendation, questionnaires, requests and invitations, speeches and ceremonies, and events. Folder labelled "People Problems" generally concern constituents' petitions for help.

The folders with the label "Speech Notes" in their title contain notes for talks given by Holsclaw to a wide variety of community service groups and organizations. Because they address what were then contemporary concerns and issues, and correspond to his efforts in the state legislature, they are found in this series.

The records in this series offer valuable historical insight into the deliberations and proceedings of the state legislature, the evolution of bills and the demands on an elected official. It is in these legislative files that the bulk of opinion, lobbying, requests for assistance and political concerns are explicated.

Series 3: Civic activities - Represents the Holsclaws' involvement in clubs and organizations, ceremonies and events, and community affairs. Some of the material details Douglas Holsclaw's support of the University of Arizona. An alumnus of the University, he served on the Board of Directors for the University of Arizona Foundation, belong to the Wildcat Club, and the Arizona Band Boosters Association and sponsored band scholarships. Included is a legislative history of the University of Arizona College of Medicine that he compiled.

Holsclaw's work on civil rights issues is represented in the series along with his continued efforts to support and promote programs dealing with alcohol and drug abuse, family planning, mental health, and the mentally retarded. There is substantial material on the Delta Chi Fraternity as Holsclaw served as a long-time adviser.

Governor Raul Castro appointed Holsclaw to the Arizona Bicentennial Commission and the former legislator arranged to have the Bicentennial Freedom Train make a stop in Tucson. The correspondence, notes and printed material he assembled can be found in this series.

Holsclaw had a keen interest in legislative affairs well beyond his tenure as an elected official and he tracked the evolution of bills and generated or received correspondence pertaining to proposed legislation. Folders labelled "Holsclaw Notes" are comprised of notes on miscellaneous subjects.

Also contained in the series in a 33 page typescript by Roy Drachman title "Tucson's Use of Land--Past, Present, and Future." "Politics and Legislative Issues" includes correspondence from Bruce Babbitt, Paul Fannin, Barry Goldwater, Carl Hayden, Mo Udall, Jack Williams, and others.

Series 4: Business activities - Contains material in the form of correspondence, notes, and business records pertaining to some of the Holsclaws' real estate holdings. The items found in the series are far from representative of the Holsclaws' capital investments and other business affairs.

Series 5: Photographs and oversize material - Consists of personal photographs, composite photographs of the Arizona State Legislatures and photographs of Arizona governors signing various pieces of legislation. Also contained in the series are several plaques received by Holsclaw for his legislative and civic achievements.
