Linda Elliott-Nelson

I am interested in serving as the President of the Arizona Historical Society (AHS) Board of Directors. As a native Arizonan, I believe strongly in this organization's mission "connecting people through the power of Arizona's history". Knowing our state's roots and past helps us center who we are and how we achieve our goals and objectives. I believe I can make a difference through focusing our efforts in a professional manner to help us work together.

There are important priorities facing Arizona Historical Society in the next year. These include the AHS sunset review, the budget, and fulfilling the AHS mission given challenges of funding, staffing, and changing times. It is key to provide calm oversight in board leadership while listening to input from the Board, the staff, and Arizonans and AHS members who reach out to our organization.

I have over 20 years of leadership as a community college administrator providing oversight with staffing of 300-400 faculty and staff and a yearly budget of over \$18 million. My positions as Vice President and Dean of Instruction necessitated working with budget planning and a diverse reporting structure and creating an environment conducive to everyone working together – both inside and outside the college – to achieve goals. I also served as Board Chair of Arizona Town Hall during 2015-2017. During my tenure, our organization implemented its strategic plan, held statewide town halls on key topics, and adjusted actions as needed given funding situations. I also serve on the AHS Rio Colorado Chapter Board, the Yuma Crossing National Heritage Area Board, and the Yuma Regional Partnership Council – First Things First.

Arizona has a powerful history. Through working together, we can connect our state residents and visitors with our past and go forward into the future successfully.

I, DeNise C. Bauer would like to become the Vice-President on the Board of the Arizona Historical Society. I have served on this Board since 2021 and believe I have the skills, knowledge and abilities to assist the President in leading the Board to reach its goals in mission accomplishment.

Although I have only lived in the State since 2012, I have gathered an enormous amount of knowledge about its history and bureaucratic policies to help define issues and opportunities that are presented to the agency. I strongly believe that the path going forward is to support the effort to include histories of all Arizonans. All of the cultures living here now and in the past have dealt with and continue to face the harsh realities, celebrate successes, and took on the challenges which were sometimes tied into human survival.

I started working with AHS when I joined the Douglas Historical Society (DHS) in 2013. I served and still serve on their Board of Directors as an Officer. My experiences with the group was a fast track to discover a many of the little-known, but important facts on how we ended up where we are today. I have a Masters in Public Administration, with coursework focused on developing and managing nonprofit organizations. It was taught that the reason for forming a non-profit is that there are serious problems or perceptions of such in society that are not being adequately addressed by the government, so more narrowly focused organizations are formed to solve problems or other issues.

I have seen that history is generally appreciated and embraced by Arizona's citizens. In Douglas, the local merchants decided that exploring the city's history is a welcome attraction to area visitors. The DHS is currently working with them to prioritize stories and develop a plan to include the city's history by explaining different types of signage which would include incorporating new technology. I figure that this fantastic plan will come to fruition about the same time internet and other communication services finish their installation. I should mention that I met with many of the local organizations when I arrived and found the Historical Society was a really good organization to work with – they have an active board, best management practices were being followed and they really appreciate my talents for problem solving.

I have seen and experienced the opportunities and challenges working with all-volunteer staffs. Motivations for working often start out at an emotional level then build from there. Volunteers want to do their best in addressing the situation. Like paid employees they have their "motivational buttons" and need to be recognized for their input. During my relatively short time with AHS, I have spoken with other Board members who had problems and I've come to realize that some communication that was needed for better understanding of how government works was missing. I think this can be better addressed during orientation. I also think that it's very appropriate to have representation from all of Arizona's counties.



I participated in the development of AHS policies, dealing with diversity and inclusion. Having been educated and exposed to a multitude of various cultures, ethnicities, and personalities give me the impetus to continue in helping with society progress towards perfection.

I think that becoming the Vice-President of AHS is a role I will be able to do well.
