SCOPE AND CONTENT NOTE: This collection consists of records and other documents associated with the Tucson Division of the Southern Pacific Railroad Company. It includes a dispatcher's ledger, two voucher books, a personnel time log, a special transport seal register ledger, and a variety of material on the Railroad Police. The time log contains the last names of 5-6 individuals and references Herbert McQueen as a special agent investigating possible employee excessive time notations for 1956. The dispatcher log contains the names of the railroad conductor, engineer, and the dispatcher. Material pertaining to Railroad Police includes the "Special Agent" promotional comic book, case notes compiled by McQueen and other agents, and information on a lawsuit filed against the Southern Pacific by a cameraman who was arrested for trespassing while covering a United Transportation Union strike. The Publications folder holds a variety of manuals, guides, labor agreements, and union bylaws, as well as the proceedings from two annual meetings of the Association of American Railroads Protective Section. A map in Box 2 Folder 1 depicts routes in the Tucson Division of the Southern Pacific for December 1930.
